Financial situation 2007

Currency

As of 2004, the financial report is presented in Euro. However, the table relating to Phase VI (Tables 4) is still presented in US\$ for consistency with financial reporting throughout Phase VI.

Contributions received for Phase VII (Table 1)

As of 31 December 2007, a total amount of €1,583,688 was received as regular contributions for Phase VII. Additional €35,000 was received as voluntary contribution from Germany (€30,000) and The Netherlands (€5,000), with an agreement to use these funds for the AEGIS project (€25,000) and for inter-regional cooperation (€10,000).

Outstanding contributions (Table 1)

As of 31 December 2007, outstanding contributions for Phase VII were €171,063 (Table 1). Outstanding contributions received as of 31 March 2008 have been highlighted with an asterisk. Apart from a few delayed contributions, the large majority of countries are regularly paying their dues. In this regard Armenia, Macedonia (FYR) and Malta represent exceptional cases with delayed payments of 2 years or more.

Expenditures in 2007 (Tables 2 and 3)

The "budget total" column represents the revised original budget defined at the onset of Phase VII, in order to include the additional voluntary contributions received from Germany and the Netherlands, as well as in order to reflect the decisions made at the Tenth Steering Committee meeting (Latvia, September 2006). At this occasion, funds for €150,971 were reallocated for AEGIS activities.

Staff expenditures, as indicated in the previous financial reports, remain higher than expected at the onset of Phase VII. The total negative figure at the end of Phase VII for staff expenditures can be estimated to be around €80,000. This will correspond to a 9% deviation from the original estimate of staff costs.

The result of expenditures for network operations is showing a total balance of €384,423. Although the networks are mobilized to carry out all their planned activities, it is not expected that all the remaining funds will be spent during 2008. The carry-over from Phase VI (see below) will also contribute to the final result of Phase VII, which is expected to be nearly even at the end of Phase VII in December 2009.

Financial status of Phase VI (Table 4)

Some remaining funds from Phase VI were used in 2007, as determined through the reallocations made at the onset of Phase VII. The last outstanding contribution from France was also received in early 2007 and as of 31 December 2007 the total carry-over amount to Phase VII is approximately US\$ 57,000.
